WHAT'S INCLUDED IN THE RESOURCE KIT?

- A customizable press release to send to your local media outlets
- Shareable social media graphics and sample social media posts
 - Image overlays to create your own social media graphics for the campaign
- A half-page flyer and a full-page printable, customizable flyer
- A suggested email to send out to your pet adopters

GETTING STARTED

Now that you've downloaded the Resource Kit, what's next?

1. Update the customizable flyer, email and press release to include your organization's logo, name and necessary contact information.
2. Send the press release to your local media contacts.
3. Include information about the Holiday Wishes campaign in your organization's print and/or email newsletters, and direct supporters to petcofoundation.org/holidaywishes to submit their story.
4. Send the Adopter Email to your supporters and ask them to submit a Holiday Wishes story.
5. Begin promoting the campaign on your social media channels using the provided graphics or use the overlays to create graphics of your own.
6. Work with your adopters to help them craft their stories and obtain high quality photos and/or video.
7. Check your email and verify adoptions whenever stories are submitted.

REVIEW LAST YEAR'S STORIES ONLINE


Read through last year's winning stories to see which were selected. Remember, great photos and videos can make a difference! Encourage your adopters to read these stories, too!

How to Participate:

1. Write your story of love in 500 words or less. Visit petcofoundation.org/holidaywishes to read prior year's winning entries and get some inspiration!
2. Include one photo of your pet by themselves, one photo of you or your family with your pet and up to two other photos to illustrate how your pet has changed your life. Pets must have been adopted from our organization, and they must be living in quality.
3. Stories can be submitted starting Aug. 15. Submit your story and photos to petcofoundation.org/holidaywishes by Monday, Oct. 1 at noon CST but hurry because only the first 10,000 stories are guaranteed to be reviewed.
4. Include our organization's contact information so that we can be eligible for a grant award!
